American Academy of Pediatrics – California Chapter

The Arc California

22 local chapters providing a wide range of human services and other supports to people with intellectual and developmental disabilities (I/DD) and their families: advocacy, residential, educational, vocational, employment, and family supports

Best Buddies California

Offers one-to-one friendship into adulthood, integrated employment, inclusive living, family support, and leadership development programs for individuals with and without I/DD

California Department of Developmental Services – Waiver Program for Individuals with Developmental Disabilities

Designs and coordinates services for Californians with developmental disabilities: counseling, lifelong individualized planning and service coordination, assistance with finding and using community resources, genetic counseling, out-of-home care planning, placement, and monitoring, and training and educational opportunities

Center for Independent Living

Supports people with disabilities: peer support, independent living skills training, information and referral, advocacy, and transition from institutions and secondary education

The FASD Collaborative

- Focuses on supporting the creation of fully inclusive communities addressing the needs of all individuals who are neurodiverse including the FASD community
- Provides virtual and in-person support groups, online webinars, and special interest groups

FASD United

- Serves as the national organization on FASD, supporting people with FASDs and promoting healthy pregnancies
- <u>Family Navigator Program</u> provides individuals living with FASDs, their family members, caregivers, supporters and professionals with expert, confidential referrals to resources and services, one-on-one peer support, and information on FASD

State of California – Department of Rehabilitation

Pre-Employment Transition Services

Offering services and accommodations to students, youth, and young adults to help them be successful, get help paying for school, and make a plan. Explore the world of work with job exploration, postsecondary counseling, skills for work, self-advocacy, and work experiences

Vocational Services

Assists individuals with disabilities to build viable careers and live independently in their community. Program provides career guidance and counseling, job search and interview skills training, independent living skills, on the job training, employment preparation, assistive technology, and other services.

Medicaid Waiver Programs

California currently has four waivers that are open to children, including a newer waiver for developmental disabilities: Home and Community Based Alternatives Waiver, HCBS Waiver for Californians with Developmental Disabilities, Self-Determination Program for Individuals with Developmental Disabilities, Medi-Cal Waiver Program

The Tanagram Way

Offers virtual social groups and activties: bingo, book club, music club, afternoon social group, caregiver corner group, pre-recorded art lessons

Special Olympics in California

Provides sports and social connections for families with FASDs and other I/DD Northern California Southern California

Wraparound Services

Develops a service plan with specific strategies for meeting the needs identified by the family. The service plan is individualized, with strategies that reflect the child and family's culture and preferences. California Wraparound is intended to allow children to live and grow up in a safe, stable, permanent family environment.
